**Directions:**

- Take I-94 to Exit 157 (Old US 12/Pierce Road Exit), drive Southwest on Old US 12 approx ¼ mile to Sylvan Rd. The road immediately past Sylvan Township Hall on your left and the Old Schoolhouse on the corner.
- Turn Left heading South 1 ½ miles to 1850 Sylvan Rd (on the right) just before the pavement ends. It is the property on the right across Chrysler's Proving Grounds Gate #2. Use the second driveway marked with the double flags.
- Follow the drive to the clubhouse.
